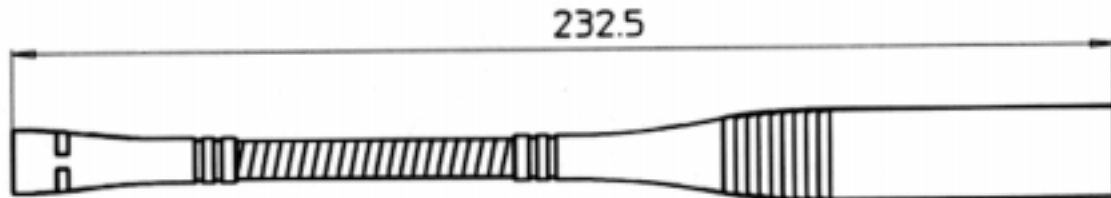


# Architect's and Engineer's Specifications

The mounting module should have a length of 232 mm (9.9 in.) and include a flexible part. A light ring shall be included, powered by phantom power, but with the possibility to be deactivated. The power module shall include a jumper for low frequency roll off and shall

terminate a 3-pin XLRM-type output connector. The colour shall be non reflective grey. The gooseneck module shall be the AKG Acoustics GN 15 E.
